## Motion in re Bonhoeffer's Theory of Stupidity

This Motion as a warning to any and all of us: "finger finger on the wall".

DIETRICH BONHOEFFER is of course the young Lutheran theologian who alone among church leaders spoke out against the election of Adolf Hitler in 1933 and who was ultimately hanged at Flossenberg concentration camp just two weeks before liberation by the Americans.

And while in prison he searched for how it had been possible to subvert a civilized society into electing a madman as their hero – and downhill from there – leading to the total destruction of any and all and everything.

Has this Court not noticed the continuously increasing numbers of criminals with "social stupidity" type of affliction coming before it?

Has this Court not noticed the disappearance of intelligent participants in attendance to watch court proceedings – and instead the appearance of bullet

proof glass at the clerk's office and tiny window slots behind the new one-way mirror at our District Attorney? Or the empty lobby at our Justice Center?

Or the barricading of all but one courthouse entrance – and no longer by only a single officer - but by a self protecting duo?

Has this Court not noticed everybody outside - attributing malice, evil, and greed – to everyone inside?

And everybody of the courthouse – certainly deriving no benefit - from such self created hell. The cause therefore has to be stupidity – communal social stupidity - by those on the "inside". No other explanation makes sense.

## Retrospect

And, coming back to Bonhoeffer and Hitler, this Defendant was a normal 8 year old German kid at the end of World War II in 1945, and came to America as a 13 year old speaking hardly any English, but as one having survived even Hitler, mainly by us hand cutting grass off the sides of the road and feeding it into our rabbits.
