


I have submitted a formal complaint to the District Attorney of Van Zandt County, and the State Commission on Judicial Conduct, and have not been able to get either to move.

Dear Mr. Birnbaum:

Thank you for your recent letter regarding the difficulties you are experiencing with the legal system. I appreciate you contacting my office in this regard.

Please know that under Texas law, the local district and county attorneys are given original jurisdiction to prosecute criminal charges within their respective counties. prosecutors are granted extensive discretion in determining which cases will be prosecuted and how those cases proceed before the Grand Jury. This exercise of discretion is not subject to review by the Office of the Attorney General. Therefore, you may wish to continue working with the district and county attorneys' offices in an effort to resolve this matter.

Furthermore, the Office of the Attorney General cannot act as an appellate body to review the rulings or conduct of a Texas judge. Ethics matters are properly addressed by the Texas Commission on Judicial Conduct. Therefore, it appears you have pursued the proper course of action by relaying your concerns to that agency.

However, the State Bar of Texas is the agency charged by law with authority to regulate attorneys in Texas. If you feel that an attorney, who is licensed in Texas, has acted in an unethical or illegal fashion, you may wish to file a grievance with the State Bar. They will review your complaint to determine if the situation warrants disciplinary action. For a copy of a grievance complaint form, you may call the Office of General Counsel of the State Bar of Texas at 1-800-932-1900.

Again, thank you for writing, and I hope the information I have provided is useful. Please feel free to contact me if I can be of assistance on any other matter.

Your Honor:

Under color of law I am being held hostage by the racketeering of an officer of the Court and the refusal of the Court to acknowledge and correct the injustice being imposed on me.

In spite of the Sheriff's report, my crime report to the District Attorney, and my pleadings to the Court complaining of false charges, I have been subjected to the following injustices:

- 1. I respectfully request your referral of this matter to the U.S. Justice Department or the appropriate Federal authorities.



I, Udo H. Birnbaum report the following crimes committed by William B. Jones against Udo H. Birnbaum and request your attention to these matters. Both Birnbaum and Jones reside in Van Zandt county and all matters referred to occurred in Van Zandt county.

A report by the Sheriff's Office styled Incident No. 95000270 dated February 8, 1995 is enclosed as documentation of these crimes.

I report the following crimes:

Jones maliciously and negligently destroyed Birnbaum's existing fence at the property line between Jones and Birnbaum for a total distance of about 350 yards. Birnbaum is a rancher who relies on this fence to control his cattle. Jones failed to give any warning to Birnbaum and the fence has been down for more than five (5) months.

Jones trespassed upon the property of Birnbaum by directing the operator of the bulldozer upon the property of Birnbaum, pushing large quantities of brush, debris, and wire fence beyond Jones' property line and up to 25 feet onto the property of Birnbaum. This is willful criminal trespassing.

Jones maliciously and negligently released large quantities of water onto Birnbaum's property by the use of dynamite to blow up a dam existing on Jones's property. Jones failed to give any warning to Birnbaum. Uncontrolled amounts of water containing sand, driftwood, and debris scoured Birnbaum's land and created ditches, gullies, and uncontrollable erosion. Large quantities of sand, driftwood, and debris remain on Birnbaum's property to this day.

I request the District Attorney of Van Zandt to refer these matters to the County Grand Jury for prosecution.
